- 2. NOTICE OF NO AGENCY RELATIONSHIP: CR Holland Property Management has previously entered into an agreement with the Property Owner(s) to provide certain real estate brokerage services through Licensee who acts as that client's designated agent. As a result, Licensee and CR Holland Property Management will not be acting as your agent.
